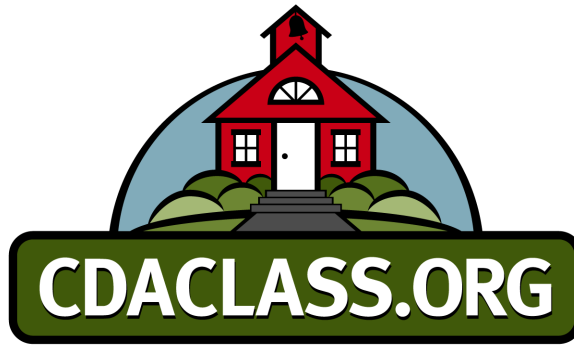

CDAClass.org Payment Plan Agreement

By signing this agreement I agree to and understand the following:

- I understand that I will make payments on the first (1st) of each month for five months until the entire tuition is paid in full.
- I understand that I am to pay five non-refundable payments totaling \$750 and I am responsible for the entire tuition balance if I do or do not complete coursework. I understand that the payments are as follows – 1st month \$150 (with application materials), 2nd month - \$150, 3rd month - \$150, 4th month - \$150, 5th month - \$150. I understand and agree that this will be automatically drafted from the credit card provided on my application form.
- If I do not pay the tuition payment due the first of each month I understand that I will be charged an insufficient funds/late payment fee of \$60.
- I understand that if my payment is overdue by twenty days I will be disenrolled from CDA classes, will forfeit all tuition paid, will not receive documentation of course participation and will still be responsible for paying the remaining tuition balance.
- I understand that payments that are overdue by thirty days will be placed into collections for the entire outstanding balance.
- I understand that I will be able to work freely on course completion but will not be able to pass module 6 of 11 without CDAClass.org receiving the entire tuition balance in full.
- I understand that I have 365 days from the date my application is received and processed to successfully complete all coursework.
- I understand that the monthly payment will be automatically drafted from the credit card I supplied when starting CDA classes on the 1st of each month until the payment is paid in full. If payment can not be drafted from the charge card account on the 1st I understand the \$60 late fee will be charge for insufficient funds. I understand it is my responsibility to ensure that there are adequate funds on the credit card for the tuition payments by 12:01 AM EST on the first of each month.
